- Entry fee:** \$30 for first event, \$10 for second. USHA members deduct \$5 each.
- Hospitality:** Each day for players.
- Rules:** All players, parents and coaches must abide by the USHA's Code of Conduct.
- Deadline:** Entries must be received by April 15 (You can sign up at first Junior Pyramid, also at Elmhurst).

- Souvenir:** USHA gloves to each entrant, plus USHA/QuJHO Membership to non Members.
- Directions:** Train -- E, F, Q, R, G to Roosevelt Ave. or 7 Train to 74th (same stop) and walk up Broadway four blocks to Elmhurst Hospital. Courts are directly across from Elmhurst Hospital front entrance.  
Car -- Take BQE to Roosevelt / Broadway Exit (70th st.) drive up either street to Elmhurst Hospital. Courts are directly across from Elmhurst Hospital front entrance (79th st).
- Format:** **Team Requirements:** Captain, form of association, ID, 5 - 10 players, Under 20, USHA membership.
- Rounds** will best of 5 consisting of 3 singles and 2 doubles, first team to win three moves on
